By signing this Agreement, the property owner designated below (“Property Owner”) agrees to the following terms and conditions for the receipt of DIRECTV® programming service(s) at the property described below (the “Property”):

- These terms and conditions are separate and apart from any terms and conditions agreed to between Property Owner and the DIRECTV Key Account Operator authorized by Property Owner (“Operator”) to install equipment and provide programming service(s) at the Property.
- Property Owner agrees to subscribe to the monthly DIRECTV programming service(s) designated in the Residential SMATV Customer Programming Order Form provided to DIRECTV by the Operator at the rate(s) set forth therein for 100% of the units at the Property.*
- Property Owner is responsible for payment of the DIRECTV programming service(s) and related fees, taxes and charges for 100% of the units at the Property.
- If the Property cancels programming service(s), Property Owner remains responsible for full payment through the date of cancellation.
- If the Property wishes to receive additional DIRECTV programming service(s), such as Analog Bulk Programming, Digital Bulk Programming, DTH Programming or A la Carte programming service(s) or upgrade packages, Operator, Property Owner or individual subscribers may be required to enter into additional written agreements or addendums.
- A corporate credit card or EFT solution will be used to facilitate all payments to DIRECTV (see page 2 of 2). By signing below, Property Owner agrees to the terms of this Agreement and consents to DIRECTV’s use to collect amounts due to DIRECTV.
- Property Owner agrees that it will not resell or rebroadcast the DIRECTV programming service(s).
- DIRECTV programming service(s) may be disconnected at DIRECTV’s discretion if the Property’s account is past due.
- This Agreement shall not restrict an Operator from charging fees for the installation and maintenance of equipment installed at the Property. Any such fees shall be governed by a separate agreement between Property Owner and the Operator.

THIS AGREEMENT IS SEPARATE AND DIFFERENT FROM ANY OTHER AGREEMENT YOU MAY HAVE PREVIOUSLY MADE WITH DIRECTV AND IS FULLY ENFORCEABLE UNDER THESE TERMS.

DIRECTV Customer Agreement: You hereby agree and acknowledge that this Agreement sets forth additional terms and conditions regarding your receipt of DIRECTV programming services and activation of access cards and shall be applied in conjunction with the DIRECTV Customer Agreement, a copy of which is provided at DIRECTV.com and with your first bill.

Arbitration: You and DIRECTV agree that both parties will resolve any disputes arising under this Agreement, the DIRECTV Customer Agreement or any addendum thereto, or your DIRECTV programming service(s), through binding arbitration as fully set forth in the DIRECTV Customer Agreement. Arbitration means you waive your right to a jury trial.

Please make sure all information is filled out completely. This Agreement will not be processed if it is not fully completed.
